Welcome to the Global Forum on Nicotine 2024: Economics, Health and Tobacco Harm Reduction. Once again you join us for this 11th edition of the conference, taking place at the Marriott Centrum Hotel, in the heart of the beautiful city of Warsaw, Poland.

Since its inception, this conference has focussed on safer nicotine products' role in helping people quit smoking. Rapid development continues in technologies that are offering consumers safer alternatives to combustible tobacco. These include vapes, oral alternatives, like nicotine pouches and new forms of snus, and heated tobacco – all generally referred to as 'safer nicotine products' (SNP). As always, GFN invites all key stakeholders to examine the individual and public health benefits of safer nicotine products, as the evidence increasingly supports their efficacy in helping people switch away from high-risk behaviours.

At GFN24 we will continue to examine the evidence concerning the use of SNP and the impact on reducing smoking and more generally on individual and public health. This year alongside health impacts, we are widening the discussion to include the economic impact of SNP, addressing a number of key questions, including:

- What are the costs of inappropriate regulation and/or prohibiting the sale and use of safer alternatives to combustible cigarettes?
- Can healthcare savings linked to safer product availability be quantified?
- Do falling tobacco tax revenues, or state-involved tobacco income, influence safer product regulation?
- Will overly-restrictive regulation drive independent manufacturers out of business - and disincentivise transnational tobacco industry transitions away from combustibles?

More generally, the conference will also address some important questions - including why tobacco harm reduction faces resistance from some sections of public health, given harm reduction's hugely positive impacts tackling the consequences of intravenous drug use and HIV/AIDS prevention.

The programme comprises keynotes and panels and will also include workshops on regional issues and specific topics, following positive feedback after their introduction at GFN23. In addition, this year we have a film festival, acknowledging the importance of different forms of communication to the development of tobacco harm reduction, as well as a stream within the programme entitled the 'Science Lab', where short videos about results of research will be shown and discussed by those who undertook and published the research.

We are pleased that once again we are able to stream much of the conference live, enabling those unable to join us to take part online, with the majority of sessions, including our workshops, also offering simultaneous translation into Spanish and Russian both for in-person and online audiences.

We believe we have a programme which offers something for everyone and one we hope will inspire constructive discussion and debate. We also have a number of social and networking events to enable participants to renew acquaintances and make new ones.

There is a lot of useful information later in this reader and as always, our team are on hand to assist you in any way they can, and we also look forward to receiving your feedback following the conference.

GFN PATRON - MR HON LIK



Mr Hon Lik is the Chinese pharmacist who invented the modern electronic cigarette. In 2001, while using high-dose nicotine patches to help himself stop smoking, he devised a system on a large console, using food additives as solvents. The challenge was managing to scale the mechanism down to a miniature size, suitable for a hand-held cigarette-sized device, and getting the right dose of nicotine while also getting the right odours from additives.

In 2000, he came up with the idea of using a piezoelectric ultrasound-emitting element to vaporize a pressurized jet of liquid containing nicotine diluted in a propylene glycol solution. Hon also proposed placing the liquid in a disposable plastic cartridge, which serves as a reservoir and mouthpiece. These inventions are the basis of the present-day electronic cigarettes. In 2003, Hon filed the first patent in China for the device and the first electronic cigarette was manufactured that year in Beijing.

MICHAEL RUSSELL



The Michael Russell Oration has been established as an annual event, delivered to honour the work and memory of **Professor Michael Russell**, one of the pioneers in the study of smoking behaviour, clinical interventions and public policy action, who died in 2009. Michael was a psychiatrist and research scientist. His achievements confirmed him as a pioneer in the study of tobacco dependence and the development of treatments to help smokers quit. The enduring impact of his work is likely to place him among the foremost clinical public health scientists of the twentieth century.

He was born in Cape Town, South Africa, and whilst working in London at the Institute of Psychiatry between 1969 and 1998, he conducted a number of highly original studies that revolutionised our understanding of both the pharmacological and psychological basis of tobacco smoking. For public health, the interventions and treatments he developed have had an enormous impact throughout the world in reducing the morbidity and mortality caused by tobacco. In the UK, his work formed much of the evidence base that inspired the new NHS Stop Smoking Services, launched in the year after his retirement. He argued that while the tobacco industry remained free to market cigarettes, millions of lives would be prematurely ended, especially in the growing markets in developing countries, before enough smokers could quit.

Based on the knowledge that pure nicotine carries little health risk, but is the main reason why people smoke, he advocated the development and promotion of safer nicotine products to the exclusion of cigarettes, to reduce the majority of harm caused by ingesting the non-nicotine toxins in burning tobacco. Michael Russell is the person who did the most to lay the foundations for tobacco harm reduction that drives much research in the field today.

Following The Michael Russell Oration, the recipient of The Michael Russell Award 2023 will be announced. The Award honours someone who has made a substantial and innovative contribution to the science and understanding of safer nicotine products and tobacco harm reduction.

THE MICHAEL RUSSELL ORATION 2024

CLIFFORD DOUGLAS



Cliff Douglas, president and CEO of Global Action to End Smoking, has dedicated his 36 year career to eradicating death and disease related to tobacco use by promoting science-based policies and education. Prior to Global Action, Douglas taught a tobacco policy course at the University of Michigan School of Public Health and directed the university's Tobacco Research Network. Last year, he produced an online tobacco course that is available globally. Douglas served as the American Cancer Society's Vice President for Tobacco Control and as Tobacco Control Policy Advisor to the U.S. Assistant Secretary for Health and the U.S. Surgeon General. His career highlights include leading the campaign to prohibit smoking on airplanes in the U.S., serving as an attorney in landmark lawsuits against cigarette manufacturers on behalf of state attorneys general and individual smokers, and successfully defending Uruguay against Philip Morris International's international trade action seeking to block that nation's tobacco control laws.

Cliff Douglas's Oration is entitled "Bridging the Divide: Taking Global Action to End Smoking."





GERRY STIMSON

Professor Gerry Stimson is a leading advocate for tobacco harm reduction and an Emeritus Professor at Imperial College London. A public health social scientist, he was one of the founders of drugs harm reduction in the 1990s, developing and evaluating the approach in response to HIV/AIDS. He has advised national governments, WHO, UNAIDS, UNODC, and World Bank on drugs, HIV/AIDS, and alcohol issues. Author of over 220 scientific publications and several books, Gerry is a Director of Knowledge•Action•Change, involved in the FSFW-funded Global State of Tobacco Harm Reduction and Tobacco Harm Reduction Scholarship Programme. He also co-founded GFN, delivered by KAC Communications since 2014.



BRAD RODU

Dr Brad Rodu is a professor of medicine and holds an endowed chair in tobacco harm reduction research at the University of Louisville, Kentucky USA. Involved in research and policy development regarding tobacco harm reduction since 1994, he has authored 70 medical publications about tobacco. A member of the James Graham Brown Cancer Center, Professor Rodu was chosen for the Michael Russell Award in recognition of his ethical and thorough approach, his work on smokeless tobacco and its relative safety and his studies involving the use of new products to help smokers switch, all of which have advanced the knowledge and understanding of tobacco harm reduction in a significant way. Professor Rodu has published in a broad range of medical and scientific journals, wrote the book, *For Smokers Only: How Smokeless Tobacco Can Save Your Life* and runs the blog Tobacco Truth.



DAVID ABRAMS

Born in South Africa, Dr David Abrams is a Professor of Social and Behavioral Sciences at New York University College of Global Public Health. With degrees in Psychology and Computer Science, David is a licensed clinical psychologist specialising in nicotine use, addictions and chronic disease prevention. Along with over 300 scholarly articles, he authored *The Tobacco Dependence Treatment Handbook*, winner of a book of the year award. Throughout a career spanning over forty years, he has specialised in harm reduction, addictive behaviour, tobacco and nicotine use and improving quality of life. His present focus is aligning complex systems forces to end smoked tobacco use behaviours and replace deadly smoking with safer smokeless modes of nicotine delivery.



LARS RAMSTRÖM

From 1967 to 1989, Dr Ramström was Director of the Swedish National Smoking and Health Association, a governmentally supported health agency dealing with research, public information and tobacco control matters. Since 1990, he has acted as Principal Investigator of the Institute for Tobacco Studies, Stockholm, Sweden, an independent consultancy focusing on research in the epidemiology of tobacco use and related policy matters. He has had extensive engagements in international activities with various international organisations including the WHO and with the ICAA (International Council on Alcohol and Addictions), and was Secretary General of the Fourth World Conference on Smoking and Health, Stockholm, 1979. He has authored numerous articles in the scientific literature and acted as reviewer for a number of medical science journals. In 1988 he received the WHO Award Medal for achievements in Tobacco Control. He was the recipient of the inaugural Michael Russell Award in 2018.

Martin Cullip is a former company director and International Fellow of the Taxpayers Protection Alliance, who has written and blogged on free market and lifestyle consumer issues for over a decade. As a user of e-cigarettes and other safer nicotine products, he is a particularly passionate consumer advocate for all forms of tobacco harm reduction and has a keen interest in the rapidly-evolving nicotine market and the politics surrounding it. Martin is a former Chair of UK educational charity The New Nicotine Alliance and has taken part in parliamentary evidence sessions and consumer, industry, and political events on the subject domestically and internationally.



CLIFF DOUGLAS

USA

Cliff Douglas, president and CEO of Global Action to End Smoking, has dedicated his 36 year career to eradicating death and disease related to tobacco use by promoting science-based policies and education. Prior to Global Action, Douglas taught a tobacco policy course at the University of Michigan School of Public Health and directed the university's Tobacco Research Network. Last year, he produced an online tobacco course that is available globally. Douglas served as the American Cancer Society's Vice President for Tobacco Control and as Tobacco Control Policy Advisor to the U.S. Assistant Secretary for Health and the U.S. Surgeon General. His career highlights include leading the campaign to prohibit smoking on airplanes in the U.S., serving as an attorney in landmark lawsuits against cigarette manufacturers on behalf of state attorneys general and individual smokers, and successfully defending Uruguay against Philip Morris International's international trade action seeking to block that nation's tobacco control laws.



CARISSA DÜRING

SWEDEN

Carissa Düring is the Director of Considerate Pouchers in Sweden, a global consumer advocacy group dedicated to promoting a smoke-free world and consumers' rights to alternative nicotine products. She studies clinical psychology at Uppsala University in Sweden. As an advocate, she writes and speaks about tobacco harm reduction from the consumer's perspective and their right to alternative nicotine products. She highlights how successful nicotine pouches have been in helping Sweden achieve the lowest smoking rates in the EU, and how the rest of the world can follow in its footsteps. Carissa has also been featured in the documentary How Sweden Quit Smoking.



CARMEN ESCRIG

SPAIN

Carmen Escrig received a PhD. in Cell Biology and Genetics from the Autonomous University of Madrid, and is the founder, coordinator, and/or scientific advisor of different organisations related to smoking harm reduction, such as the Spanish Medical Platform for Smoking Harm Reduction, composed of about 30 doctors, professors, and health professionals, as well as the Spanish Association of Personal Vapourisers Users (ANESVAP). She is the organiser of THR SUMMIT SPAIN, the first scientific congress on smoking harm reduction in Spain, now in its second edition. She has attended or participated as a speaker in several congresses related to tobacco harm reduction. Carmen also collaborates actively with users and scientific organisations in Latin America.



SHARIFA EZAT WAN PUTEH

MALAYSIA

Professor Dr. Sharifa Ezat Wan Puteh is the Chairman of the Malaysian Society of Harm Reduction. As Professor of Public Health (Health Management and Health Economics) at National University of Malaysia, she is well-versed with the burden of non-communicable diseases on Malaysia's health system and recognised as a prominent figure in public health, specialising in policy, economics, and medicine. As the Chairman of MSHR, she brings a wealth of experience and knowledge to the table, particularly in advocating for tobacco harm reduction and abstinence from nicotine addiction. Professor Dr. Sharifa earned her postdoctoral degree in Health Economics from the United Nations University-International Institute for Global Health (UNU-IIGH). She has served in significant roles including as Deputy Dean of the Faculty of Medicine for International Relations, President of Malaysia's Society of Harm Reduction (MSHR), and as a consultant to governmental bodies on various health-related matters, including occupational diseases and hospital efficiency.



ANDRZEJ FAL

POLAND

Andrzej Fal graduated from the Medical University and the University of Economics in Warsaw. He followed post-doctoral studies at Johns Hopkins University, USA and has also been trained at the National Heart and Lung Institute, in London. Prof. Fal is head of the Department of Allergy, Lung Diseases and Internal Diseases, National Institute of Medicine in Warsaw. He has published over 350 papers on allergy, pulmonology, public health, and is the founder and Editor in Chief of "Public Health Forum". Prof. Fal is a member of the Board of Directors of the GLIMMER Initiative, and on behalf of the Polish Ministry of Science was a member of the Board of the Polish-American Fulbright Commission. He was also a member of the European Medicinal Agency of the Committee for Advanced Therapies. Since November 2014 he has been the President of the Polish Society of Public Health.



KONSTANTINOS FARSALINOS

GREECE

Konstantinos Farsalinos, MD, MPH, is a physician and senior researcher specialising in Public Health at the Universities of Patras and West Attica in Greece. He has conducted extensive research on smoking, tobacco harm reduction, and vaping since 2011, publishing over 90 studies and articles. Notably, he authored the first systematic review on the safety and risk profile of e-cigarettes in 2014; his research was influential in shaping the EU's regulatory framework on vaping. In 2020, he was recognized as a Highly Cited Researcher for his significant impact in global science. During the pandemic, he published studies exploring the relationship between smoking, nicotine, and COVID-19.



IAN FEARON

UNITED KINGDOM

Ian is an independent consultant with expertise in regulatory and scientific aspects of nicotine and tobacco products. His consulting work encompasses clinical and behavioural studies of tobacco and nicotine products for regulatory submissions in the US and Europe, and he has a wealth of experience of both consumer goods and medicinal licensing submissions. His 16 years working in the Tobacco Harm Reduction arena has included roles as Senior Director of Clinical and Regulatory Affairs EMEA with JUUL Labs, Director of Tobacco Research with Celerion, and Principal Scientist and Head of Clinical Research at British American Tobacco. As well as his consulting, Ian is a Scientific Advisory Board Member with Qnovia, a medtech startup seeking authorisation for a novel NRT in the UK and the US, and is also an Independent Non-Exec Director with Advanced Inhalation Rituals (AIR), a global shisha manufacturer.

Jonathan Fell has followed developments in the tobacco and nicotine industries for 30 years. He began his career as an equity research analyst covering tobacco and other consumer industries at Merrill Lynch, Morgan Stanley and Deutsche Bank, and from 2013 to 2022 he was a founder and portfolio manager at Ash Park, an investment manager focused on investments in the fast-moving consumer goods industry. Jon now spends his time as a consultant in the tobacco and nicotine spheres (currently including a project for the Foundation for a Smoke-Free World) and as a director / trustee in the not-for-profit sector, including Article 36, a UK-based organisation working to promote public scrutiny over the development and use of weapons.



MAREWA GLOVER

NEW ZEALAND

Professor Marewa Glover is one of New Zealand's leading tobacco control researchers. She has worked on reducing smoking-related harm for 31 years. She is recognized internationally for her advocacy on tobacco harm reduction; and locally was a Finalist in the New Zealander of the Year Supreme Award in 2019 recognising her contribution to reducing smoking in NZ. In 2018, Dr Glover was appointed Tobacco Section Editor for the Harm Reduction Journal. In that year she also established the Centre of Research Excellence: Indigenous Sovereignty & Smoking an international program of research aimed at reducing smoking-related harms among Indigenous peoples globally. The Centre's research was funded with grants from the Foundation for a Smoke-Free World, Inc. ("FSFW"), a US nonprofit 501(c)(3) private foundation.



WILL GODFREY

USA

Will Godfrey is the founding editor-in-chief of Filter (<https://filtermag.org>), an online magazine that launched in 2018 to cover drug use, drug policy and human rights through a harm reduction lens. He's also the executive director of The Influence Foundation, the nonprofit behind Filter. He previously founded The Influence, an award-winning drug policy news site, and ran Substance.com and the addiction-focused site The Fix. Before that, he co-founded an award-winning print publication for incarcerated people in London. He has consulted for numerous organisations in the drug policy and harm reduction space. He lives in New York.



SUMMER HANNA

USA

Summer Hanna, PhD serves as Head of Scientific Regulation on behalf of BAT. She is responsible for Group-wide scientific engagement to drive the awareness and acceptance of Tobacco Harm Reduction and the development of science-based regulatory approaches for reduced risk products globally. Dr. Hanna has held a variety of US and Global roles across Scientific Research & Development and Regulatory Affairs. She most recently led the development of the cannabinoid discovery science programme as part of BAT's Beyond Nicotine strategy. Previously, Summer led teams within Reynolds' FDA Submissions & Engagement team focused on their smokeless tobacco portfolio, along with previous roles in Analytical Research. Before joining Reynolds American in 2011, Hanna received her PhD in Analytical Chemistry from Wake Forest University. She currently serves as treasurer to the US Technical Advisory Group for ISO/ TC 126.



GEORGE HARDIE

USA

George Hardie is Executive Director of tobacco harm reduction research for Dr Vince Clinical Research based in Kansas City. He has over 37 years in the science arena, with 23 years as a pre-clinical toxicologist where he holds an MSc in Applied Toxicology. He has an extensive background in the respiratory field where he was previously Head of Inhalation Toxicology for Pfizer. George migrated into clinical research 13 years ago and has participated in pharmaceutical studies with Astrazeneca and consumer healthcare studies with GSK. More recently he was the head of clinical research for British American Tobacco. He is highly regarded in the harm reduction field, where he has extensive knowledge and experience in all aspects of nicotine and tobacco harm reduction. George has contributed to multiple PMTA and MRTPA projects and has also authored/co-authored 20 peer-reviewed papers in tobacco harm reduction.



JESSICA HARDING

UNITED KINGDOM

Jessica Harding became involved in tobacco harm reduction when vapes helped her to quit smoking, in 2012. She helped to establish the political party Vapers in Power and later worked as an administrator for the New Nicotine Alliance. Jessica is a Director at Knowledge•Action•Change and its sister company KAC Communications, which runs the Global Forum on Nicotine. She previously worked as an English teacher and lives in the UK.



KARIN JACOBSON

SWITZERLAND

Karin Jacobson is Science Engagement Director at Japan Tobacco International (JTI) and based in Geneva, Switzerland. In her role, Karin leads scientific engagement activities, develops external scientific messaging and drives understanding of tobacco and nicotine product science. Prior to joining JTI in 2017, Karin built extensive experience in pharmaceutical science. She worked as a research scientist in pharmacology at the University of Geneva and in the biotechnology company NovImmune before transitioning to the consulting company NeuroAssets, specialized in neuroscience. As a senior consultant, she provided expertise and guidance on research strategy, preclinical study design and scientific communication. Originally from Sweden, Karin holds a PhD in Pharmaceutical Science from the University of Basel, Switzerland.

Ian Jones is the R&D Scientific Product Assessment Center Vice President at Japan Tobacco International (JTI), based in Kanagawa Japan, and is responsible for leading JTI R&D's fundamental chemical, material and biological research activities. Ian joined JTI in 2006 from the University of Bath, UK, where he was a lecturer in Developmental Neuroscience at the Department of Biology and Biochemistry. Since then, Ian has held several regulatory science-related roles in the company, including Reduced-Risk Science Vice President and R&D Principal Scientist. Ian has a particular interest in the harm reduction potential of oral tobacco- and nicotine-containing products and has participated in several cross-industry activities to develop, for example, harmonized terminology and product standards for smokeless tobacco products. Ian holds a PhD in cell physiology, completed at Imperial College, London (1995).

KAZAKHSTAN

Gintautas-Yuozas Kentra graduated from Almaty State Medical Institute as a general practitioner. He has since completed advanced training in cardiology, public health, healthcare management, and healthy lifestyle development. Beginning his career as an emergency medical specialist, Dr. Kentra then served in the therapeutic department of Almaty City Hospital as a physician and deputy chief physician. From 1996 to 2000, he worked at the Kazakhstan Embassy in the UK as a medical doctor. He later headed the medical service of the Criminal Executive System of the Ministry of Justice in Almaty. Social psychologist & IT specialist, author of publications on psychology, data analysis and harm reduction. Since 2003 Grzegorz has managed international projects in the area of public health, drugs and tobacco harm reduction. Between 2012 and 2018, he was lecturer at the Faculty of Management and MBA School, University of Warsaw. Since 2016, Grzegorz has been a member of the European Network for Research Evaluation in the Social Sciences and the Humanities (ENRESSH), part of the COST Action: European Cooperation in Science and Technology. Grzegorz is also Co-founder of a harm reduction knowledge hub at harmreduction.eu.

Michael Landl is the Director of the World Vapers' Alliance (WVA), a global advocacy organization dedicated to representing the interests of nicotine consumers and promoting harm reduction through vaping. He is a staunch advocate for vaping as a safer alternative to smoking and works tirelessly to raise awareness about its public health benefits. In his role, Landl leads the WVA's support for vaping advocacy groups worldwide, engages with policymakers and regulators to foster sensible vaping regulations, and frequently provides expert commentary on vaping-related issues in the media. He is also a regular speaker at various conferences and events. Prior to his tenure at the WVA, Landl studied at the University of St. Gallen and gained experience in public affairs, including working in the German Parliament.



IGNACIO LEIVA

CHILE 

Ignacio Leiva is a journalist specialized in informatics and multimedia platforms. In 2010, he led the communication campaign to prevent the vaping ban in Chile. Since then, he has focused on strengthening the community of electronic cigarette users, making them more informed and aware. He is the founder and current president of the Association of Vaporizer Consumers of Chile (ASOVAPE) and serves as the secretary of ARDT Iberoamerica. He organized the first pro-vaping public demonstration in Latin America and promotes communication campaigns for tobacco harm reduction in Chile and worldwide. Ignacio has been an active and relevant actor in the legislative process concerning electronic cigarettes in Chile, significantly contributing to policy discussions. He is also the manager of the broadcasts for World Vaping Day (WVD) and Vapefest Online. Currently, he is the general content editor and activities coordinator for the campaign "Vaping is not Smoking," a multimedia communication effort carried out in Chile and aimed at Latin America.

Nancy Loucas' THR advocacy began in 2015 as one of the founders/co directors of Aotearoa Vapers Community Advocacy (AVCA) in New Zealand, doing battle for the rights of vapers to be able to access what they need to become/remain smoke free. Nancy is also the founder and Executive Coordinator for the Coalition of Asia Pacific Tobacco Harm Reduction Advocates (CAPHRA). CAPHRA supports consumer THR advocacy organisations and activities throughout the Asia Pacific region and beyond, and has developed various programmes for consumers including the Voices4Vape online seminar series, sCOPE consumer livestream, and the recurring stream that runs during the FCTC COP. Nancy also writes and produces the Advocates Voice online newscast and the Advocates Voice Live sessions. CAPHRA, under Nancy's leadership, also established the collaborative "Right2Vape" testimonial database with CASAA in the USA, and the "Right to Switch" change.org petition, both featuring thousands of consumer testimonials from across the world.



DAVID MACKINTOSH

UNITED KINGDOM 

David MacKintosh has over 25 years' experience of working on alcohol and drug policy, which has included working within the UK Cabinet Office (UKADCU), heading up the London Drug and Alcohol Policy Forum (LDAPF) and providing specialist advice to the Greater London Authority. He also spent six years as Head of Community Safety for the City of London and has served as a trustee of a number of charities addressing substance use problems. He has helped deliver a range of innovative campaigns and national best practice guidance, which have all had one common purpose, to reduce harm to individuals and communities. JOSEPH MAGERO

KENYA

Joseph Magero is a dynamic public policy expert and dedicated harm reduction fellow committed to pioneering progressive solutions in the field of public health. With a keen focus on evidence-based strategies, Joseph has emerged as a trailblazer in advocating for pragmatic policies that mitigate the adverse effects of various societal challenges. Driven by a passion for public health and a desire to effect meaningful change, Joseph has been instrumental in raising awareness and championing evidence-based strategies for tobacco harm reduction. Heneage Mitchell, commonly known as 'H', has been resident in Asia for over 40 years. He spent most of those decades working in regional media, including as managing editor and co-publisher of Tobacco Asia, a trade publication reporting on the regional tobacco industry. In 2012, he established factasia, an independent, not-for-profit, consumer-oriented regional advocacy for rational debate about – and sensible regulation of – the rights of adult citizens throughout the Asia-Pacific region to choose to use tobacco or other nicotine-related products. Heneage smoked for over 45 years before switching to vaping in 2016, since when he has never touched a cigarette.



EMMANUEL MWAPE

ZAMBIA

Emmanuel Mwape, a Zambian filmmaker born in Lusaka in 1992, is renowned for his impactful storytelling on tobacco harm reduction. He's an alumnus of the Tobacco Harm Reduction Scholarship program and a Kevin Molloy Fellow. Experienced in both fiction and non-fiction, Mwape employs film to spark conversations and effect social change. His award-winning works include "Saving Chalo" and "Helping Chalo," which delve into the complexities of tobacco harm reduction. Mwape's films not only captivate audiences but also serve as catalysts for advocacy, prompting reflection and dialogue. Through his dedication to amplifying marginalized voices, Mwape has become a luminary in the Zambian film industry, utilizing his craft to shed light on pressing social issues and inspire action worldwide.



ETHAN NADELMANN

USA

Described by Rolling Stone as "the point man" for drug policy reform efforts and "the real drug czar," Ethan Nadelmann, JD, PhD is widely regarded as the outstanding proponent of drug policy reform in the United States and abroad. After teaching politics and public affairs at Princeton University (1987-1994), he founded and directed first The Lindesmith Center (1994-2000) and then the Drug Policy Alliance (2000-2017). He also co-founded the Open Society Institute's International Harm Reduction Development program. Ethan has published extensively and spoken publicly in roughly forty states and forty countries. His TED Talk has over two million views. Ethan and his colleagues were at the forefront of dozens of successful campaigns to legalize marijuana, reduce the incarceration of drug law offenders, advance harm reduction approaches to drug use and addiction, and otherwise promote alternatives to the war on drugs. Ethan hosts the leading podcast about all things drugs: PSYCHOACTIVE. And he has become increasingly engaged in the debate over tobacco harm reduction.



TOMÁS O'GORMAN

MEXICO

Tomás O'Gorman is a Mexican lawyer and teaches Corporation Law and Successions Law at Universidad Panamericana in Mexico City. An ex-smoker and vaper since 2016, he is co-founder of "Pro-Vapeo Mexico", a Mexican consumer association (registered in 2017), that advocates for tobacco harm reduction and non-combustible alternatives. Maria Papaioannoy is the founder and spokesperson of Rights 4 Vapers, Canada's largest vape movement. Fiona Patten was a member of the Victorian parliament in Australia from 2014 to 2022. She campaigned on harm reduction policies for 30 years and ran the adult industry association (Eros) for 20 years. She initiated and delivered reforms including voluntary assisted dying, abortion law reform, the decriminalisation of sex work and drug law reform. Since leaving parliament she has continued to work on social reform issues including medicinal cannabis, drug harm reduction including for tobacco, criminal justice reform and greater separation of church and state. In 2018 she published her autobiography 'Sex, Drugs and the Electoral Roll'. She is also the owner of a registered wildlife sanctuary.



SUD PATWARDHAN

INDIA / UNITED KINGDOM 

Dr Sudhanshu Patwardhan ("Sud") is a licensed medical doctor and healthtech entrepreneur. Sud qualified as a doctor from India, did post graduate studies at the Keck Graduate Institute, California, USA, and holds an MBA from the London Business School, UK. For the past two decades, he has lived and worked in three continents, doing senior roles in research, strategy and policy in the pharmaceutical and tobacco industries. In 2018, Sud co-founded the Centre for Health Research and Education (CHRE), an independent healthcare company working globally in cancer prevention. 



